LEARNING & SUPPORT ASSISTANT JOB SPECIFICATION

Purpose of Role:

To provide high-quality support to pupils with special educational needs and disabilities (SEND), including those with profound and multiple learning disabilities, physical disabilities, or other complex needs. This role involves supporting pupils' learning, independence, safety, and wellbeing, including personal care, medical needs, and participation in a broad range of school activities.

Key Responsibilities and Expectations:

1. Supporting Teaching and Learning:

- Assist teachers in delivering personalised learning activities in line with pupils' IEPs/EHCPs.
- Support pupils in whole-class, small-group, or one-to-one settings to enable engagement and participation.
- Implement strategies recommended by teachers, therapists, or specialists.
- Prepare, organise, and maintain teaching and learning resources, including sensory equipment and access technology.

2. Personal and Medical Care:

- Support pupils with personal care, including toileting, changing for activities such as swimming, and other hygiene or care needs.
- Administer prescribed and emergency medications following training, risk assessments, and school procedures.
- Receive and undertake training in administering medications, emergency care, seizure management, and other health-related procedures as required.
- Provide support in the pool for swimming sessions where appropriate, ensuring pupil safety at all times.

3. Behaviour and Pastoral Support:

- Promote positive behaviour and support pupils' social, emotional, and personal development.
- Encourage independence, self-regulation, and participation in daily routines.

4. Health, Safety, and Safeguarding:

- Maintain a safe, hygienic, and inclusive environment for pupils.
- Follow school policies and statutory guidance regarding safeguarding, health and safety, and equality.

- Report any concerns about pupils' welfare, safety, or wellbeing immediately to the designated safeguarding lead.

5. Collaboration and Professional Development:

- Work closely with teachers, therapists, and other professionals to provide coordinated support for pupils.
- Contribute to the class team, demonstrating strong team work, supporting other TAs and PCAs.
- Engage in ongoing professional development, including training in emergency care, medication administration, and specialised SEND strategies.
